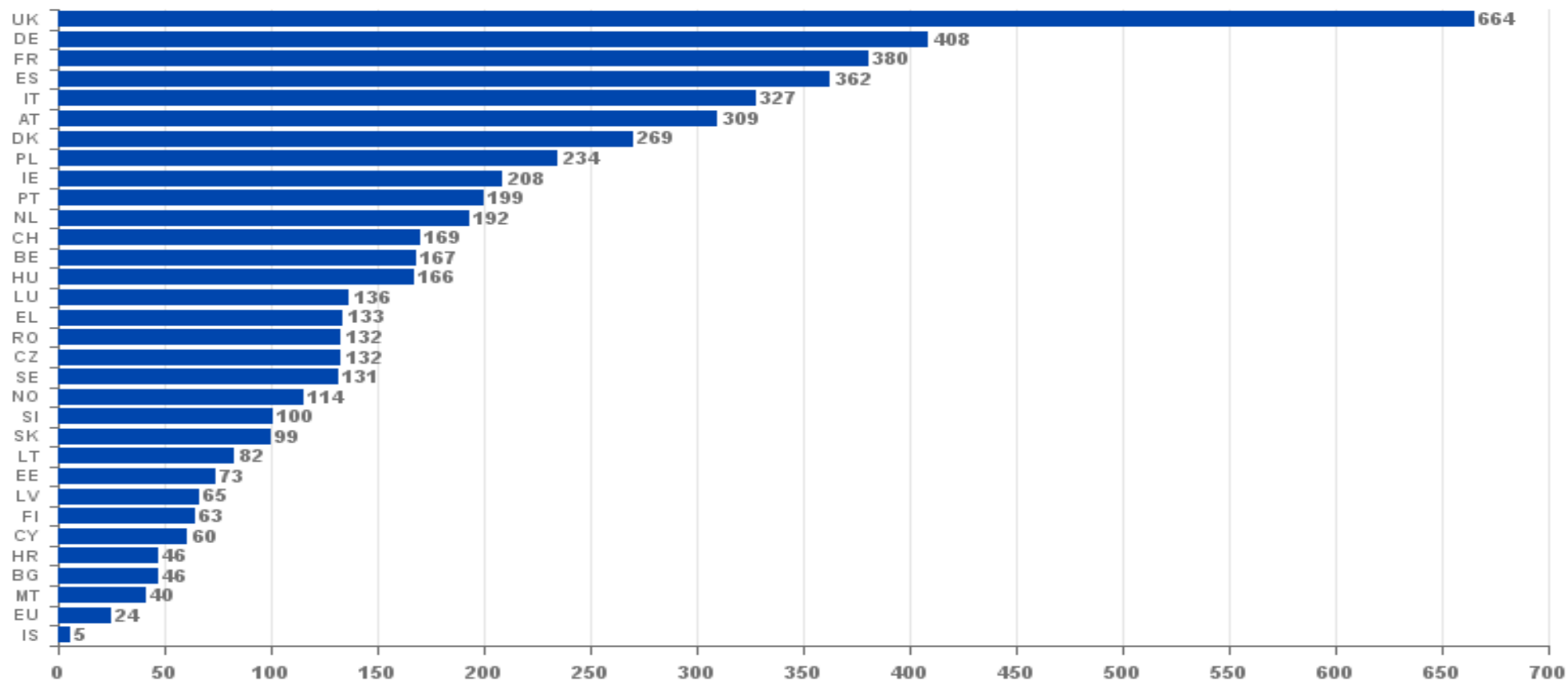


## NUMBER OF PRODUCT AUTHORISATIONS BY MEMBER STATE

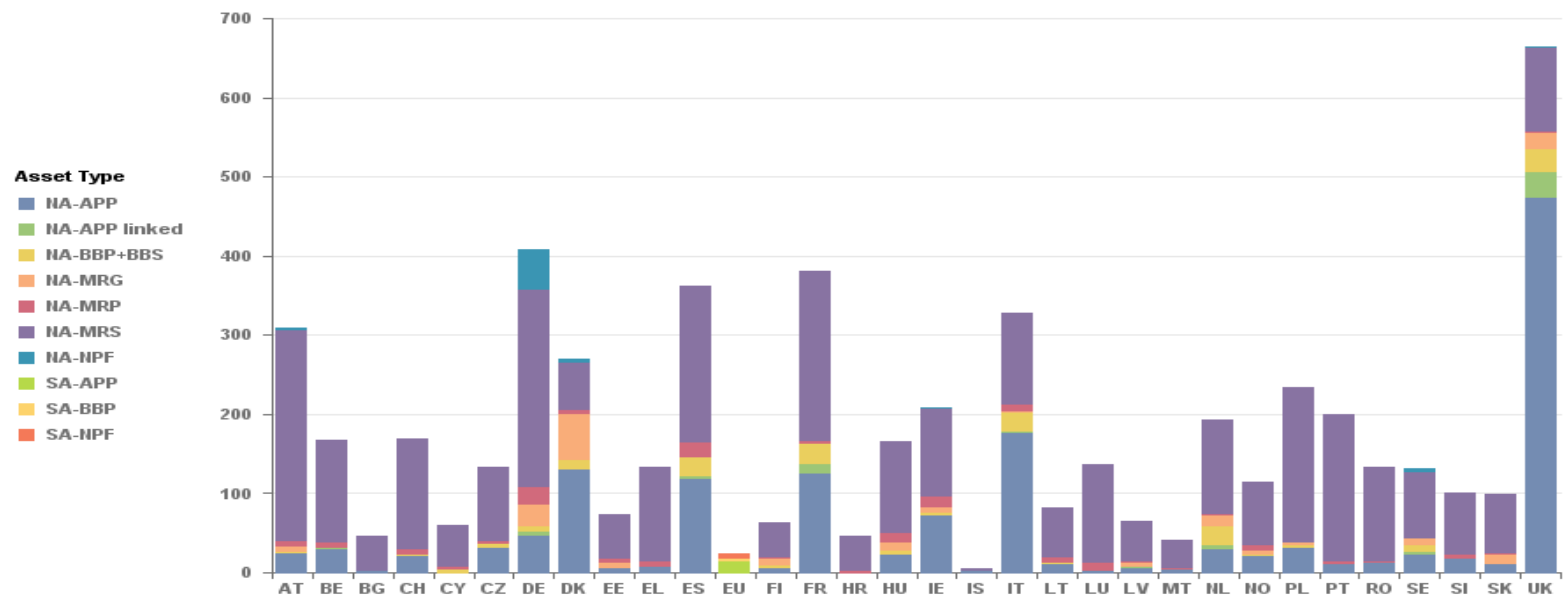

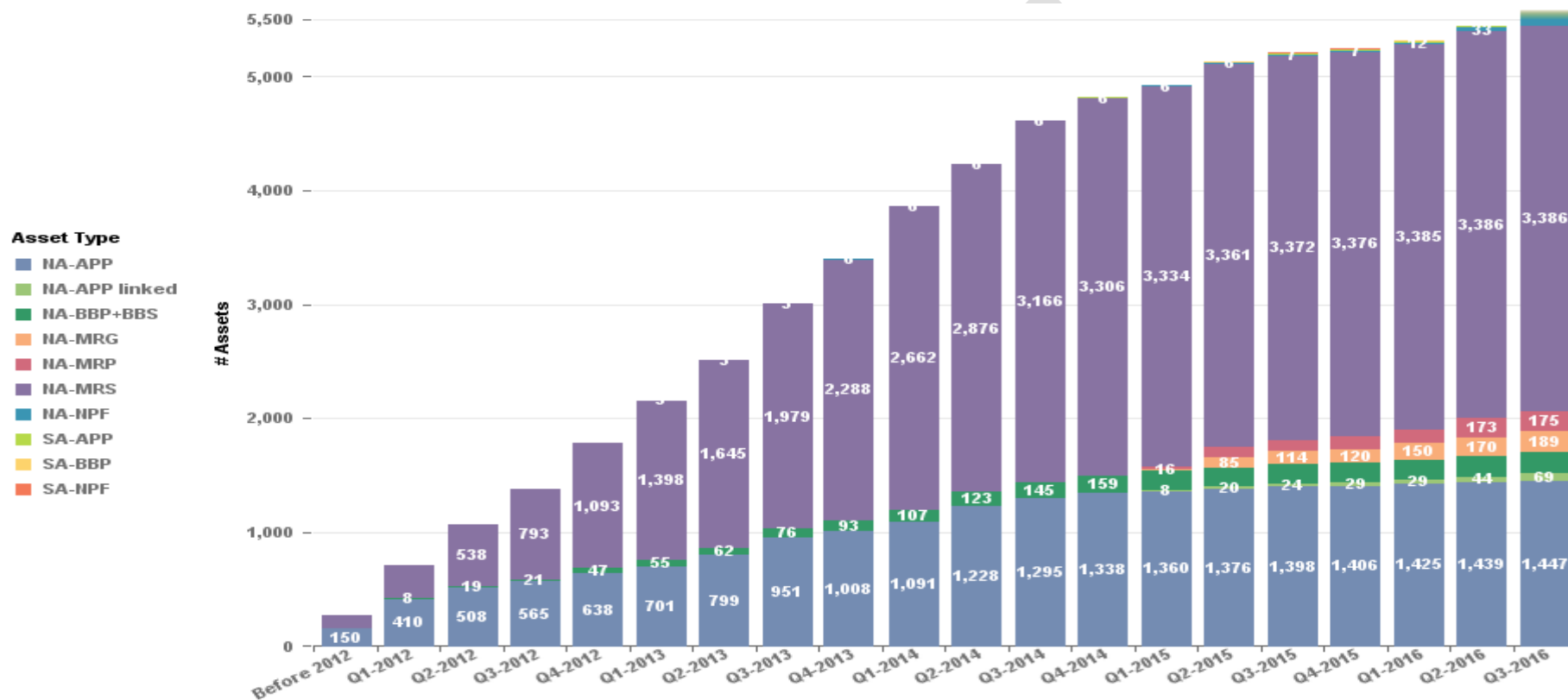

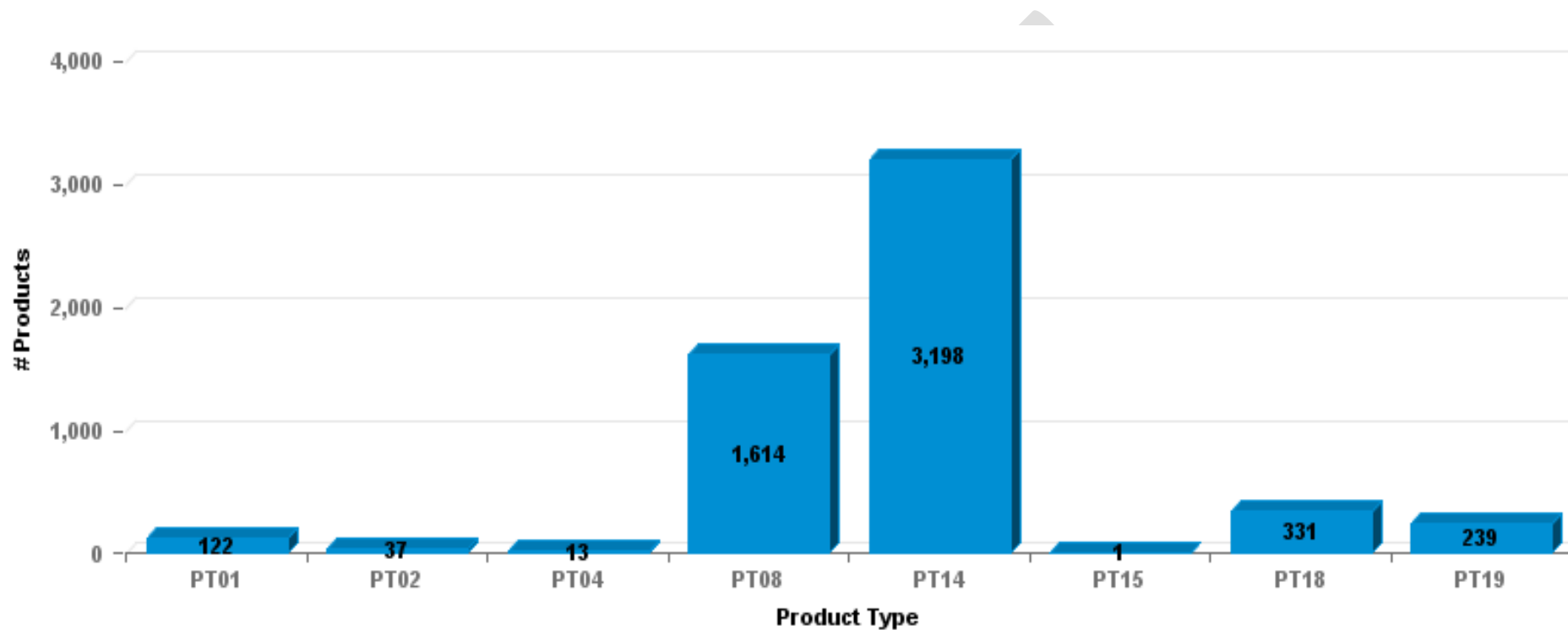
