## NOTE FOR THE ATTENTION OF THE MEMBERS OF THE IED ARTICLE 75 COMMITTEE

Consultation on a draft standardisation request (draft Commission Implementing Decision) as regards methods for the measurements of PCDDs/PCDFs and dioxin-like PCBs, total gaseous mercury and formaldehyde in support of Directive 2010/75/EU

The Commission has prepared the enclosed draft standardisation request (draft Commission Implementing Decision) as regards methods for the measurements of PCDDs/PCDFs and dioxin-like PCBs, total gaseous mercury and formaldehyde in support of Directive 2010/75/EU of the European Parliament and of the Council<sup>1</sup>.

The initiative will be adopted in accordance with the procedure laid down in Article 22(3) of Regulation (EU) 1025/2012 on Standardisation<sup>2</sup> and Article 5 of Regulation (EU) 182/2011 on laying down the rules and general principles concerning mechanisms for control by Member States of the Commission's exercise of implementing powers<sup>3</sup>.

According to Article 10(2) of the above-mentioned Standardisation Regulation, the committee set up by the corresponding Union legislation, when such a committee exists, or sectoral experts, must be consulted on a draft Commission Implementing Decision, before it is voted by the Committee on Standards of Regulation (EU) 1025/2012 on Standardisation.

Therefore, ahead of the consideration and vote on the draft Commission Implementing Decision in the Standardisation Committee, I invite the representatives of the Article 75 Committee of the Industrial Emissions Directive to share their comments on this draft Commission Implementing Decision by **14 June 2021 at the latest** by email to <a href="ENV-IED@ec.europa.eu">ENV-IED@ec.europa.eu</a>.
